FORMATION MODEL PROFESSIONAL COMPETENCE IN STUDENTS

- 3. Methodological contains original theoretical principles on which was designed by the formation of professional self-determination of senior pupils in the process of preparing the profile, including methodological approaches and principles of the system, as well as didactic research. Formative feature is aimed at developing the motivational potential of creating pedagogical conditions for the emergence and sustained desire to master high school students chosen profession corresponding to his ideas about success and social significance. The implementation of the structural-functional model will be successful if the following pedagogical conditions: the organization of training in the conditions of a common educational space "school - vocational training institutions - employers"; inclusion in the process of learning the complex training and production tasks, including the invariant part (technology courses), variable part (elective courses); psychological and pedagogical support of students, which includes professional information, vocational guidance counseling

- and heuristic activities. Resource function enables each student to get acquainted with the material and technical base of educational institutions and industrial enterprises in the region, supporting a resource center.
- 7. Efficient determines the success of the developed model and is aimed at checking the effectiveness of the formation of professional self-determination of senior pupils. Learning outcomes are considered from the standpoint of professional and social formation and determine the level of progress of basic competence in a particular field of activity as the particular student and the group as a whole.
